

SCHOLARSHIP INFORMATION & APPLICATION



POLICY

Daramalan College, at the discretion of the College Board, will make available a number of scholarships each year to:

- students whose family's current financial circumstances would otherwise prevent the student from attending the College; and
- who have strong academic or personal attributes that would enable the student to make a significant contribution to the life of the College.

GUIDELINES

The number, duration and type of scholarships to be offered will be determined on an annual basis by the Board based on recommendations from the Board Finance Committee.

- A Scholarship Committee, will be chaired by the Principal, who has processing responsibilities.
- The number and extent of scholarships will be subject to approval by the Board
- Scholarships will be advertised and included in the Daramalan College Prospectus.
- A scholarship application may be made by an enrolled family experiencing difficult financial circumstances, or a new family.
- The financial situation of each scholarship holder is to be reviewed annually.
- Scholarship negotiations with families will be conducted in total confidence.







APPLICATION INSTRUCTIONS

Scholarships currently being offered relate to opportunities to enrol at Daramalan in 2018. The value of the scholarships will be an amount which goes towards College fees.

Eligibility for scholarships will include:

- On-going enrolment at the College
- A willingness to support the Ethos of the College
- A demonstrated commitment to academic studies
- Evidence of engagement in co-curricular activities and/or school community events
- An excellent attendance record
- No significant behavioural issues

Parent(s) / Guardians are required to submit with this form:

- The last two school reports for the applicant
- A statement from the applicant, of no more than 500 words, outlining why they would like to attend / continue at Daramalan
- A statement outlining applicant's involvement in Co-Curricular activities including any leadership positions held over the past two years
- Supporting documents relating to the family's financial position

Applications will be assessed by the Principal, Business Manager and a Board representative.

All applications and associated negotiations will be strictly confidential between the parties involved.

Applications close on 30 June 2017.
